

a-FinChoice, okuwuphiko lwenkampani yakwa-HomeChoice (Pty) Ltd, bangumhlazeki wezinizakalo zezimali ogunyazive (FSP na 48448). Abakwa-Guardrisk Life bangumhlazeki wezinizakalo zezimali ogunyazive. Abakwa-FinChoice, okuwuphiko lwenkampani yakwa-HomeChoice, bangumhlazeki wezikwiletu orajistriwe (NCRCP 454). Abakwa-FinChoice bakuthuthaza ukubolekisa ngemali okwenziwa ngokulandela inkambiso elungileyo, ngakho-ke ukuhlazekwa kwesikwiletu kukuzenziswa kuphela ngokubona kwabo-FinChoice futhi isamba semali angabolekwa yona sinike ezimveni eziqondene naye ngayo njengomuntu oboleka imali.

Lena yimigomo nemibandela yesikwiletu sokubolekwa imali sakwa-FinChoice. Isitatimende Esandulela Isivumelwano kanye Nekhwotheshini, okwenziwa ngokuthi kuqoshwe izwi noma ngokusebenzisa uhlelo-kusebenza lwekhompuyutha, futhi ozonikezwa nekhophi yakho ebalhwe phansi, kubandakanya nesigunyaziso sokudonswa kwesitatimende kwi-akhawunti yasebhangwe, nekhoti leka-Yokubolekwa Imali (uma ikhona) kanye nale migomo nemibandela, kuqapha isivumelwano sokubolekwa imali esiphakathi kwakho nenkampani yethu ("isivumelwano sokubolekwa imali"). Qaphela ukuthi silhlinzeka ngezinhlobo ezihlukahlukene zemikhiazizo yemali ebalekisiyo, kubandakanya imikhiazizo yemali ebalekisiyo ekhokhelwa esikhathini esifushane, imikhiazizo yemali ebalekisiyo engahambisani nesibambiso kanye nomkhiazizo wokubolekisa ngemali esivubiza nge-MobiMoney, Konke lokhu kuzalawulwa yile migomo nemibandela yemali ebalekisiyo eqondene nobhobo ngalunye lwemali ebalekisiyo. Uma kuthiwa "wena" kushiwo umuntu owenze isivumelwano sokubolekwa imali nenkampani yethu, futhi "abakwa-FinChoice" noma "thina" kusho inkampani yakwa-FinChoice (Pty) Limited, okuwuphiko labakwa-HomeChoice (Pty) Limited. Uma sikhuluma "nge-HomeChoice Group" kushiwo noma iyiphi inkampani engeyabakwa-HomeChoice International PLC (HIL) ngokuphelele noma abangenxenyi yobunikazi kuoyona kanye nanoma iyiphi inkampani engaphansi kwabo.

1. Imigomo ejwayelekile

- 1.2. Uma ufuna ukufaka isikhaziso sokungaculiseki ngenzelo zethu, ungakwenza lokho ngokushayela uMlawuli Kazwelonke Wezikwiletu kule nombolo 0860 627 627 noma ushayele inkampani yethu kule nombolo 0861 346 246.
- 1.3. Sabelana nama-credit bureau (izinkampani ezigcina umlando wabathengi abathenga ngesikwiletu) alandelayo ngolwazi oluphathelele nesicelo sakho, isivumelwano sokubolekwa imali, ukhulelaka kwakho ukuthobela imigomo yesivumelwano sokubolekwa imali kanye nokuhoxiswa noma ukupheliswa kwesivumelwano sokubolekwa imali:

- 1.4. Qaphela ukuthi ama-credit bureau ahlinzeka ngephrofayili yakho yokuthenga ngesikwiletu futhi kungenzeka ahlinzeka nangesibalo samaphuzu abonisa ukufaneleka kwakho ukhulizeka ngesikwiletu, futhi lokhu kususelwa olwazini esabelana ngalo nawo ama-credit bureau.
- 1.5. Thina njengenkampani kanye naye njengekhasimende, singena esivumelanani sokubolekana imali, esisenze ngocingo noma ngohlelo-kusebenza lwekhompuyutha, emahhovisi ethu, ngenkathi wena wamukela imigomo yemali ebalekisiyo.
- 1.6. Ngokwemigomo ye-NCA kanye nezinqanobomgomo zethu zangaphakathi zokuhlazeka ngesikwiletu, futhi ngokubona kwethu, singanquma ukubolekwa imali noma singakuboleki imali.
- 1.7. Njengengenxenyi yenaboku yokucutshungulwa kwesicelo sakho sokubolekwa imali, kungenzeka thina abakwa-FinChoice senze lokhu okulandelayo:
 - 1.7.1. Sixhumane nanoma ngubani ukuze sihlale futhi siphinisekise ukuthi iyaziqinisekile yini iminingwane oyihlinzekile; nokuthola iminingwane kunoma ngubani mayelana nesimo sakho sezimali kanye neminingwane yakho yasebhangwe, kufaka phakathi nerekhodi lakho lokuthenga ngesikwiletu kanye nomlando wakho wokukhokhela izikwiletu;

 - 1.7.3.2. uma kubalulekile futhi kungaba wusizo emphakathini ukuba siludalule ulwazi lwakho;
 - 1.7.3.3. uma usihlinzeka ngemvume noma uma usicela ukuba siludalule ulwazi lwakho; noma
 - 1.7.3.4. uma kufanelekile ukuba abakwa-FinChoice noma enye inkampani ethola lolu lwazi, baludalule noma baluthole ulwazi lwakho.
- 1.8. Abakwa-FinChoice bayumelekile futhi ukwabaleka neminingwane yakho kanye nolwazi lwakho oluphathelele nokuthenga ngesikwiletu, nezinye izinkampani ezingaphansi kwe-HomeChoice Group ngenhlobo yokwenza ibhizinisi, futhi wena uyavuma ngokucacile futhi uyaqonda ukuthi lokhu kungenzeka kubandakanya ukuba lezi zinkampani zixhumane naye ngayo ngocingo noma ngohlelo-xhumano lwekhompuyutha ngezinhlobo zokukhangisa imikhiazizo yazo kuwena.
- 1.9. Uma ushade ngomshado wobunikazi bempahla obulinganayo, noma ushade ngomshado wesintu, uyaqinisekisa ukuthi uyitholile imvume yowakwikhokho yokwenza isivumelwano sokubolekwa imali nabakwa-FinChoice.
- 1.10. Kungenzeka iguquke imigomo nemibandela yethu ngezikhathi ezithile. Imigomo nemibandela yethu yakuwama iyatholalaka kuleli kheli www.finchoice.mobi futhi ungacela ikhophi yakho ngokufonela kule nombolo 0861 346 246. Uma njengamanje uyikhasimende lethu noma ubudake uyikhasimende lethu esikhathini esedule futhi uma njengamanje wenza isivumelwano esisha, isivumelwano sakho esisha sizalawulwa yimigomo nemibandela ebekiwe noma esebenzayo ngaleso sikhathi ozongena ngaso esivumelanani esisha.
- 1.11. Noma iluphi uguquko oluzokwenziwa kwisivumelwano sokubolekwa imali luzoba ziyibopho ngokusemthethweni kuphela uma thina sesikwilele ngalolo luguquko njengoba i-NCA iyalela ukuthi kube njalo.
- 1.12. Abakwa-FinChoice babolekisa ngemali yokuthi uyisebenzisele izidingo eziqondene naye kuphela, hhayi ukwenza ibhizinisi. Ngakho-ke, ungenza isivumelwano nathi sokubolekwa imali kuphela uma leyo mali oyibolekile uzooyisebenzisa izidingo eziqondene naye.

2. Isitatimende Esandulela

2.1. Isivumelwano kanye Nekhwotheshini Phakathi kwakho nokuzonikezwa ulwazi oluqondelayo kwiSitatimende Esandulela Isivumelwano kanye Nekhwotheshini mayelana nazo zonke izivumelwano zokubolekwa imali:

2.1.1. Isamba esimali oyibolekile: lesi yisamba semali esizokubolekwa yona ngaphansi kwesivumelwano sokubolekwa imali;

2.1.2. Imali yokuvula isikwileti: lena yimali esizokukhokhisa yona ngokuvunyelwa wuMthetho, okuyimali yezindleko zokuqalisa inqubo yokwenziwa kwesivumelwano sokubolekwa imali. Le mali ungayikhokha ngaphambi kokuba unikezwe imali oyibolekile, noma-ke siyinqe emalini oyibolekile uma sesiqala ukusebenza isivumelwano sokubolekwa imali, ukuze uyikhokhe ngamancinane njengengenxenyi yesitatimende sakho esikhokhwa nyangazonke. Mayelana ne-MobiMoney, kungenzeka ukuba sivume ukukhokhisa imali yokuvula isikwiletu kuphela ngaleso sikhathi ozoyisebenzisa ngaso i-MobiMoney, ukuze uyikhokhe ngokufanele ngokuthi unakho ukubolekwa imali esizokubolekwa imali esiphakathi kwakho nenkampani yethu.

2.1.3. Imali yeyasivisi: lena yimali esingakukhokhisa yona nyangazonke, noma sikukhokhise yona ngenkathi sikuhlazeka ngeyisivi ethile noma sikukhokhise yona njalo ngonyaka, ngokuvunyelwa wuMthetho, okuyimali yokukhokhela izindleko esingene kuzona zokulawula isivumelwano sokubolekwa imali. Isamba semali yeyasivisi ehambisana nesivumelwano sakho sokubolekwa imali ozokukhokhisa yona sizohlizeka kwiSitatimende Esandulela Isivumelwano nakwiKhwoteshini;

2.1.4. Izinga lenzalo: izinga lenzalo elihambisana nesivumelwano sakho sokubolekwa imali ozokukhokhisa lona lizohlizeka kwiSitatimende Esandulela Isivumelwano nakwiKhwoteshini. Inzalo ibalwa ngokubheka imali esele esikwilelini nsukuzonke bese yengezwa esikwilelini njalo ngenyanga (ifakwa nyangazonke phezu kwebhalansi yemali esele esikwilelini). Uma kusalele esivumelwano sokubolekwa imali esiphakathi kwakho nenkampani yethu, kungenzeka sikukhokhise inzalo esaleni esisele emvuma ngokwenzinga lenzalo eliphelele elivumelekile ngoMthetho;

2.2. Ngaphezu kowazi uluhlizeka kwisiqeshana 2.1, sizokunikeza ulwazi oluqondelayo kwiSitatimende Esandulela Isivumelwano nakwiKhwoteshini, oluphathelele nezivumelwano ze-MobiMoney;

2.2.1. Umkhawulo wesikwiletu wamanje: lesi yisamba esiphelele semali ongayikhokha (withdraw) noma nini. Lo mkhawulo sizobubeka ngokubona kwethu, emva kokuhloa amanda akho okukhokha imali oyibolekile kanye nokubheka izinqanobomgomo zethu zangaphakathi zokuhlazeka ngesikwiletu futhi kungenzeka siwukhuphule lo mkhawulo ngezikhathi ezithile uze ufinyelele emkhawulweni opehele wemali angobolekwa yona – futhi lokhu kuncike kwindlela okhokhela ngayo isikwiletu opehele;

2.2.2. Umkhawulo ophakeli: wemali angobolekwa yona: lesi yisamba esiphakeli sokubolekwa imali thina esibona ukuthi wobala nomananda okusikhokhela.

2.3. Qaphela ukuthi ikhwoteshini yethu ebalhwe kwisitatimende Esandulela Isivumelwano nakwiKhwoteshini yenziwe ngokubheka umkhawulo opehele wemali angobolekwa yona. Maqondana ne-MobiMoney, lokhu kusho ukuthi isitatimende sakho ozosikhokha nyangazonke negeke neze sibe ngaphezu kwesamba onikezwe sona kwikhwoteshini, kodwa kungenzeka sibe ngaphansi kwemali ebalhwe kwikhwoteshini, futhi lokho kuncike ekutheni uyisebenzisa kanjani i-MobiMoney.

3. Izivumelwano Sokubolekwa Imali - Okujwayelekile

3.1. Ngenkathi ufaka isicelo sakho sokubolekwa imali soquqala, thina sizokwenza ucwaningo lokuhlola ubungozi bokubolekwa imali kanye nokuhlola ukuthi uzokwazi yini ukubuyisa imali oyibolekile njengoba ulandelayo kudingekile ngokuyibolekile.

3.2. Mayelana nezivumelwano zemali ebalekisiyo ekhokhela esikhathini esifushane kanye nemali ebalekisiyo engahambisani nesibambiso, lolu cwango lokuhlola amanda akho okukhokha yilona alozotesshenziswa ukuthatha isinqumo esifanele mayelana nomkhawulo opehele wemali angobolekwa yona ("umkhawulo opehele wemali ongayibolekwa"), ngokwaziqonobomgomo zethu zangaphakathi zokuhlazeka ngesikwiletu kanye nezidingo ze-NCA.

3.3. Umkhawulo kungo opehele uququke ngokuhamba kwesikhathi ngenxa yokuguquka kwesimo sakho sezimali.

3.4. Emva kokwenza nathi isivumelwano sokubolekwa imali, kungenzeka ube sethubeni lukubolekwa enye imali, ukuze kufinyelele lukubamba esiphelele semali ongayibolekwa. Ngokwezinqanobomgomo zokuhlazeka ngesikwiletu ze-HomeChoice Group wena uvumelele ukuba noma nini ube nesivumelwano sokubolekwa imali esizwabizwa ngaphandle kwemikhiazizo ethile, enjengezivumelwano ze-MobiMoney ne-FoneChoice noma i-"KwikAdvance" okuthunyanayo ngayo kwisesigaba (6). Uma kusenebhalansini yemali esele esikwilelini sakho ngenkathi ufaka isicelo sokubolekwa imali engezinye, kumele uyikhokhe yanke leyo

mali esele esijngemanini sakho sokubolekwa imali onaso njengamanje ngaphambi kokuba ukwazi ukwenza isivumelwano sokubolekwa imali esisha. Uvumelekile ukuba usicela ukuthi usisebenzise imali yesikwiletu sakho sokubolekwa imali esisha ukukhokhela lesi soquqalelo sokubolekwa imali onaso njengamanje, leyo mali ezosala lapho izofakwa kwi-akhawunti yakho yasebhangwe. Lesi samba semali ezofakwa kwi-akhawunti yakho yasebhangwe sibizwa nge-"ngesamba se-KwikDraw". Nakuba lesi kuzoba isivumelwano esisha sokubolekwa imali, siyawabonelela lawo makhasimende nesibambiso sokubolekwa imali esikhona njengamanje ngoba imali yokuvula isikwiletu ozokhokhela yona eqondene nesivumelwano sokubolekwa imali esisha izonqunywa ngokubheka isamba se-KwikDraw kwihla esikhundleni sokuba usiswela kwisamba esiphelele ebalekewe ngaphansi kwesivumelwano sokubolekwa imali esisha. Kungenzeka sikwaziwe ngezikhathi ezithile ukuthi malini eyisamba se-KwikDraw okungenzeka ubolekwa yona. Njalo uma wenza isicelo sokubolekwa imali esisha, sizokwenza olunye ucwaningo lokuhlola ukuthi uzokwazi yini ukubuyisa imali oyibolekile. Isamba se-KwikDraw uzonikezwa sona kuphela uma ucwaningo lokuhlola lukhombisa ukuthi uzobala nawo amanda okukhokha imali ozoyibolekwa ngaphansi kwesivumelwano sokubolekwa imali esisha. Asikwazi ukuqinisekisa ukuthi noma kanjani kukhona imali ozobolekwa yona noma nini – lokho kuzonikeka ekhulolweni okuzokwenziwa ngenhlobo yokubheka ukuthi uzokwazi yini ukukhokha imali oyibolekile futhi kuzoya ngokwezinqanobomgomo zethu zangaphakathi zokuhlazeka kwesikwiletu.

3.2. Ngaphambi kokuba wenze isivumelwano sokubolekwa imali esisha nabakwa-FinChoice kumele uvumele futhi uqinisekise ukuthi uzinqonda ngokuphelele izindleko kanye nobungozi obuhambisana nokwenza esinye isivumelwano sokubolekwa imali, kanye namalungelo akho nezibopho onazo ngaphansi kwesivumelwano sokubolekwa imali esisha.

3.3. Uma ucingo ngobaza ukuthi esisiguqukile yini isimo sakho sezimali, noma unobungozi ubungozi kanye nezindleko zokwenza isivumelwano sokubolekwa imali noma amalungelo akho kanye nezibopho onazo ngokwemigomo yaleso sivumelwano sokubolekwa imali, kumele ufanele abakwa-FinChoice kuqala ku 0861 346 246 ngaphambi kokugena esivumelanani sokubolekwa imali.

3.4. Nakuba kungadingekile ngokomthetho, kungenzeka sikunikeze isikhathi sobuka ucabungule futhi uhlaize isivumelwano ngenkathi wenza isivumelwano sokubolekwa imali okokuqala nathi, futhi ngalesi sikhathi uvumelekile ukhoxisa isivumelwano ngaphandle kokukhokhisa inhlawulo.

4. Izivumelwano Zokubolekwa Imali – ze-MobiMoney

Le mibandela iqondene ikakhulukazi nezivumelwano zokubolekwa imali ze-MobiMoney:

4.1. Uma siphumelele isicelo sakho sokubolekwa imali, thina sizokunikeza umkhawulo wesikwiletu "wamanje" ("current") kanye nomkhawulo wesikwiletu "ophelele" ("maximum").

4.2. Kungenzeka sisiphelise isivumelwano sakho se-MobiMoney emva kokukunikeza isicelo sokuthi ukhiphe imali kanye kuphela. Lokhu kusho ukuthi singakuthumela isicelo noma nini sokuthi uvumelekile ukuphinda ukhiphe imali kanye kuphela ngaphambi kokuba siphelelewe yisikhathi isivumelwano se-MobiMoney, okusho ukuthi ngeke usavumelele ukuphinda imali ngaphansi kwesivumelwano se-MobiMoney emva kwaleli thuba lokugcina onikezwe lona lukhuphisa imali.

4.3. Umkhawulo wesikwiletu wamanje kanye nomkhawulo wesikwiletu opehelele sizowubala ngokubheka umphumela wocwaningo esilwenzile lokuhlola ukuthi uzokwazi yini ukukhokha imali obolekwe yona kanye nezinqanobomgomo zethu zangaphakathi zokuhlazeka ngesikwiletu. Ngeke neze sikucele ukuthi ukuthi isitatimende esingaphezulu kwaleso esithole ukuthi ungaba nawo amanda okusikhokha, kodwa-ke njalo uma ukhipha imali, ungaqoka ukukhokha imali oyikhuphile ngesikhathi esifushane kunaleso esibekewe okudingeka ukhokhe ngaso.

4.4. Umkhawulo wesikwiletu wamanje wumkhawulo waqoba (actual) esizokunikeza wona ozohlala ungenekamanini yethu noma nini, futhi kungenzeka lokhu kube yisamba esingaphansana kwesamba somkhawulo wesikwiletu opehelele, futhi lokho kuzohambisana nesimo sobungozi bakho bokuhlazeka ngesikwiletu esizosihlonza ngokubheka imithetho yethu yobungozi bokubolekisa ngemali.

4.5. Ngakho-ke kungenzeka ukuthi emva kokubheka isimo sobungozi bakho bokuhlazeka ngesikwiletu ngenkathi kwenziwa isivumelwano se-MobiMoney, ngokubona kwethu, siwukhuphule noma siwehlise umkhawulo wakho wesikwiletu wamanje, kepha-ke uma sikwenza lokho neke neze umkhawulo wesikwiletu wamanje ube esizulu komkhawulo wesikwiletu opehelele.

4.6. Umkhawulo wesikwiletu opehelele yisamba esihlonzwe ocwangcinyeni esilwenzile lokuhlola amanda akho okukhokha imali oyibolekile, kepha-ke ngenhlobo yokulandela inkambiso elungileyo yokubolekisa ngemali futhi ngenhlobo yokwaka ubudlelwano phakathi kwethu nekhasimende obuzoqhubeka isikhathi eside, wonke amakhasimende ethu siwahlinzeka ngomkhawulo wesikwiletu wamanje ophansi, ekuqaleni, futhi sizowukhuphula kancane kancane ngokuhamba kwesikhathi ngokubheka isimo sobungozi bakho bokuhlazeka ngesikwiletu. Kungenzeka noma nini abakwa-FinChoice bakumise ukufinyelela kwakho ku-MobiMoney uma uhlelekile ukukhokha imali oyibolekile ngesikhathi esibekewe futhi kungenzeka bayivula i-akhawunti yakho ye-MobiMoney emva kokukunikeza isicelo sezinsuku zosebenzi ezisishumi, kepha-ke nakuba kunjalo isivumelwano sokubolekwa imali sizokubheka yisibambiso ngokusemthethweni kuze kufike isikhathi lapho usiyikhokhe ngokuphelele yanke imali oyikwilelayo ngaphansi kwesivumelwano sokubolekwa imali. Kungenzeka futhi sikumise ukufinyelela nokusebenzisa kwakho i-MobiMoney uma izinqanobomgomo zethu zokuhlazeka ngesikwiletu zibonisa ukuthi usengcupheni yokuthi ugcine usunesikwiletu esingaphezulu kwamandla akho uma singakuvumela ukuthi uqubekwe nokukhuphisa imali.

4.7. Uvumelekile ukuba usibhalenze incwadi usicela ukuba sinciphise umkhawulo wakho wesikwiletu opehelele futhi usitshele ngokucacile ukuthi ufuna umkhawulo wesikwiletu opehelele ongakanani.

5. Ukufaka isicelo sokubolekwa imali ngokusebenzisa uhlelo-xhumano lwekhompuyutha

5.1. Kungenzeka sikuvumelele ukuthi ufake isicelo sokubolekwa imali ngokusebenzisa zokukhokhela kwakho, i-itheni nathi noma ezinye izinhlobo zohlelo-xhumano lwekhompuyutha ("uhlelo-xhumano lwekhompuyutha"). Uma ufaka isicelo sokubolekwa imali ngohlelo-xhumano lwekhompuyutha ulwazi luzaqoqa, luthunyelwe, lwamukelwe futhi lugcinwe ngekompuyutha.

5.2. Uma uqoka ukufaka isicelo ngohlelo-xhumano lwekhompuyutha, kumele uzikhethile inombolo eyimfihlo ozofinyelele ngayo olwazini olugcinwe, njenge-PIN noma iphasiwedi (password). Kumele uyigcine ngokuphelele le mininingwane futhi uqinisekise ukuthi ihlala iyimfihlo. Abakwa-FinChoice bazothatha ngokuthi zigunyazwe nguwena futhi zenziwe nguwena zonke izivumelwano zokubolekwa imali ezenze ngohlelo-xhumano lwekhompuyutha usebenzisa inombolo yakho eyimfihlo yokufinyelela olwazini olugcinwe. Kumele usazise ngokushesha uma uthola ukuthi i-PIN noma iphasiwedi yakho ihlelekile noma ilwe ezandleni zomuntu ozokubheka yemali oyibolekile umthwalo wezindleko ezibandakanya wukusetshenziswa kwe-PIN noma iphasiwedi yakho ngendlela engokunyaziwe kuze kufike isikhathi lapho usazisizile ngalokhu.

5.3. Abakwa-FinChoice banelungelo lokusebenzisa noma iyiphi inqubo yokuqinisekisa iminingwane yakho abacabanga ukuthi idingekile ngenhlobo yokuqinisekisa iminingwane yekhasimende ngenkathi ufaka isicelo sokubolekwa imali ngokusebenzisa uhlelo-xhumano lwekhompuyutha.

6. Ukukhokhwa Kwemali Ebalekile

6.1. Kumele ukhokhe isamba esiphelele semali okuvunyelwane ngayo ngenkathi kwenziwa isivumelwano sokubolekwa imali, futhi lokhu kubandakanya imali oyibolekile, nazo zonke izindleko eziphathelele nesikwiletu kanye nenzalo ngokwemigomo ye-NCA.

6.2. Ngenkathi ufaka isicelo sokubolekwa imali, uvumile ukuba abakwa-FinChoice bamise izidingo eziye kwi-akhawunti yakho yasebhangwe ngokuzonikezwa kanye yanke imali okumete ubakhokhela yona, Abakwa-FinChoice basebenzisa uHlelo Lokudonswa Kwemali Ebhangwe Ngaphambi Kwesikhathi Olungadluliselwe (NAEDO) futhi kungenzeka bacubungule ukusebenza kwe-akhawunti yakho yasebhangwe ukubheka ukuthi kunemali eyanele yini uma befuna ukudonsa isitatimende. Lokhu kuhambisana nale migomo elandelayo:

6.2.1. Mayelana ngezikhathi zethu yemali ebalekisiyo yesikhathi esifushane ekhokhwa esikhathini esiyinyanga eyodwa ("KwikAdvance"), isitatimende sakho kumele usikhokhe ngendlela ovumelane ngayo nathi ngenkathi ufaka isicelo sokubolekwa imali futhi uyavumela ukuthi sidonse isitatimende kwi-akhawunti yakho yasebhangwe ngosuku okuvunyelwane ngalo;

6.2.2. Mayelana nazo zonke ezinye izinkokhelo zesitatimende, uma usuku lwakho lomhlobo, isizodonsa imali lwi-akhawunti yakho yasebhangwe ngeLwesihlanu olwandulela usuku omhlobo. Kuzokwenza olwandulela ezinye izithi mayelana nezisambiso 6.2.2.2 – 6.2.2.4 uma usuku esivamise ukudonsa ngalo isitatimende

6.2.2.1. lungoholide, sizodonsa imali kwi-akhawunti yasebhangwe ngosuku olwandulela iholide;

6.2.2.2. lumhlaka-1 enyangeni, sizodonsa imali kwi-akhawunti yakho mhaka-30 ngenyanga eyandulela lolu suku;

6.2.2.3. lumhlaka-31 enyangeni, sizodonsa imali kwi-akhawunti yakho yasebhangwe mhaka-30 enyangeni;

6.2.3. Kungenzeka ukuthi ngoDisemba umhlobo wakho wukhohle ngaphambi kwesikhathi esijwayelekile futhi uyavuma ukuthi sicubungule ukusebenza kwe-akhawunti yakho ukuze sibonelele kwenza umhlobo bese sidonsa imali kwi-akhawunti yakho yasebhangwe noma nini emva komhlaka-10 Disemba, ngaphandle uma usazisile ukuthi uzokwathola ngaluphi usuku umhlobo wakho kuDisemba;

6.2.4. Uma kusalele emva ukukhokhela kwe-akhawunti yakho yokubolekwa imali, abakwa-FinChoice banelungelo lokudonsa imali ebhange nganoma iluphi usuku ngenhlobo yokudonsa lwe mali esalele emvuma emalini ekhona kwi-akhawunti yakho yasebhangwe. Kumele usazise ngokushesha noma kwenzeka kuba noguquko mayelana ne-akhawunti yakho yasebhangwe noma usuku lwakho lomhlobo ukuze nathi siququke iminingwane yokudonswa kwemali ebhange ngendlela efanelekile ukuze ihambelane noguquko olwenzeka.

6.4. Awuvumelekile ukuvula i-akhawunti yakho yasebhangwe, ngaphandle uma usinikezile iminingwane yenye i-akhawunti yasebhangwe esizodonsa kuona imali oyikwilelayo.

6.5. Awuvumelekile ukhoxisa uhlelo lokudonswa kwemali kwi-akhawunti yakho yasebhangwe kuzo kufike isikhathi lapho usiyikhokhe ngokubheka imali oyibolekile ngokwemigomo yokusebenzisa sokubolekwa imali.

6.6. Uma wenze izivumelwano zokubolekwa imali ezingaphezulu kwesivumelwano nabakwa-FinChoice: futhi uma kwenzeka kuba khona isivumelwano sokubolekwa imali esidonsa okusalele

emvuma ukukhokhela kwawo, uyasinikeza imvume yokuthatha imali ekhokhwe ngokwefile kwenye yama-akhawunti akho siyifake kwi-akhawunti okusalele emvuma ukukhokhela kwawo noma siyifake kwi-akhawunti esenebhalansi yemali esele futhi engakakhokhwa ngokuphelele;

6.6.2. Uyasivumela ukuba sidonse isamba esisodwa kwi-akhawunti yakho yasebhangwe mayelana nemali oyikwilelayo kuwona wonke ama-akhawunti akho, bese emva kwalokho siyihlukanisa leyo mali ukuqinisekisa ukuthi ukukhokhela kwawo wonke ama-akhawunti akho akusaleli emvuma, uma lokho kunokwenza;

6.6.3. Uma ungasithelanga ukuthi iyiphi i-akhawunti uyikwilelayo sokubolekwa imali ofuna ukuyikhokhela, thina sinelungelo lokuthatha isinqumo sokwabala imali oyikhokhile ngendlela esibona ngayo.

6.7. Kumele ukhokhe isamba esiphelele semali enqunyelwe, ngohlelo lokudonswa kwemali kwi-akhawunti yakho yasebhangwe ngesikhathi esibeke. Uma kwenzeka kuba khona inkinga mayelana ne-akhawunti yakho yasebhangwe noma mayelana nokufakwa komhlobo wakho ebhange kumele uxhumane nathi ukuze usebenzise ezinye izindlela zokukhokhela okungenani kusalele zinsuku zokusebenza ezintathu ngaphambi kosuku lokukhokhwa kwesitatimende olunqunywe ukuze ugweme ukusebenzisa kwenzalo eyinhlawulo noma izindlela zomthetho.

6.8. Uma kwenzeka usicela ukuthi sihlale kabusha ukukhokhela kwesikwiletu sakho sokubolekwa imali futhi uma sikuvuma lokho ukucelayo, isivumelwano sokubolekwa imali esihlele kabusha sizalawulwa yimigomo kanye nemibandela esivumelane ngayo thina kanye naye. Isinqumo sokuhlalela kabusha kwesikwiletu sizothatha kuphela uma sikubona kufanelekile ukuthi sikwenze lokho. Ngokulandela lokho okushiwo kwisiqeshana 6.6, noma iyiphi inkokhelo yesitatimende evala kuwena izokwabawu ngale ndlela elandelayo: izosethenziswa ukukhokhela
