- Uma kukhulunywa ngesikhathi sokulinda kushiwo isikhathi, esisukela ngosuku oqale ngalo ukusebenza umshwalense (usuku lapho umuntu ovikelwe ngumshwalense engena khona esivumelwaneni sepholisi yomshwalense) kanti ngaphansi kwalo mhlomulo, lapho kufakwa khona isicelo somshwalense kungekho mhlomulo oyokhokhwa ngumshwalense.
- Uma uhoxiswa umshwalense futhi uvuselelwa kabusha ngokuhamba kwesikhathi, izikhathi zokulinda zizoqala phansi ngosuku ovuselelwe ngalo umshwalense, futhi ngeke neze abakwa-Guardrisk bachezuke kulokhu.

Uhlobo lwemali yokukhokhela umshwalense kanye nokusebenza komthetho

- Ama-premium kanye nemihlomulo okumele kukhokhwe ngaphansi kwale pholisi kuzokhokhwa eRiphabhulikhi yaseNingizimu Afrika futhi kumele kukhokhwe kuphela ngemali yegamaRandi yaseNingizimu Afrika.
- Le pholisi izolawulwa futhi ihunyushwe ngokweMithetho yaseNingizimu Afrika futhi ezinkantolo zeRiphabhulikhi yaseNingizimu Afrika.

Umkhawulo wendawo osebenza kuyona umshwalense

- Umuntu ovikelwe ngumshwalense kumele kube ngumuntu ohlala eRiphabhulikhi yaseNingizimu Afrika ukuze avikeleke ngaphansi kwale pholisi. Ukuvikeleka ngaphansi komshwalense kubandakanya nokuvakashela emazweni angaphandle kwaseNingizimu Afrika kodwa lokho kumele kube ukuvakasha okuzothatha isikhathi esingaphansi kwezinyanga ezintathu (3).
- Umuntu ovikelwe ngumshwalense ongesona isakhamuzi saseNingizimu Afrika, futhi ongenya umhlali osemthethweni ohlala kuleli lizwe ngokugcwele futhi esikhathini esiningi ohlala ngaphandle kwelizwe laseNingizimu Afrika ngeke avikeleke ngaphansi kwale pholisi.

Izenzo Zobugebengu

- Abakwa-Guardrisk ngeke nangephutha babe nesibophu sokukhokha ngaphansi kwale pholisi uma isicelo sokukhokhela singumphela wesenzo sokuphulwa ngamabomu komthetho olwa nobugebengu, kungakhathelekile ukuthi lowo ngumthetho oshaywe yiphalamende ngokusemthethweni noma umthetho wendabuko (kubandakanya nokukhwananisa), esenziwe yinkampani ehlinzeka ngezikweletu noma esenziwe ngumuntu ovikelwe ngumshwalense noma ngomunye umuntu osezina

egameni lenkampani ehlinzeka ngesikweto noma egameni lomuntu ovikelwe ngumshwalense noma ngemvume yakhe, noma esenziwe yinoma imuphi omunye umuntu ofaka isicelo sokukhokhelwa umhlomulo ngaphansi kwale pholisi.

Ukuqamba amanga, ukunikaze incazelo engelona iqiniso noma ukugodla ulwazi olusemqoka

- Isenzo sokuqamba amanga, ukunikaze incazelo engelona iqiniso noma ukugodla ulwazi olubalulekile noma ukugodla ulwazi oluhlobene nezimo eziphathelele nale pholisi noma oluphathelele nescielo sobulungu bale pholisi noma isicelo sokukhokhelwa ngaphansi kwale pholisi, kungaholela ekuhoxisweni kwale pholisi noma sichithwe isicelo sokukhokhelwa noma kuholele ekuthathweni kwepholisi njengento eyizeleze kusukela ngesikhathi oqale ngaso ukusebenza umshwalense futhi wonke ama-premium akhokhiwe ngeke abuyiselwe emuva kumuntu owakhokhile.
- Uma kukhona umhlomulo okhishwe ohlobene nanoma isiphi isenzo sokuqamba amanga, ukugodla ulwazi olubalulekile, ukunikaze incazelo engelona iqiniso noma isenzo sokukhwanisa esenziwe yinkampani ehlinzeka ngesikweto, noma umuntu ovikelwe ngumshwalense noma omunye umuntu ofake isicelo sokukhokhelwa umhlomulo ngaphansi kwale pholisi, lowo muntu kumele awukhokhe noma awubuyise lowo mhlomulo anikezwe wona. Isikhathi esiyizinsuku ezingama-30 sokuhlaziya nokucubungula ipholisi yomshwalense

- Uma singekho isicelo sokukhokhelwa osifakile ngaphansi kwale pholisi noma uma lingekho iilungelo osulitholile lokufaka isicelo sokukhokhelwa, ungayihoxisa le pholisi kungakapheli izinsuku ezingama-30 (amashumi amathathu) emva kokuthola le ncwajana, ngokuthi uxhumane nenkampani esimele (i-binder holder) uyazise ukuthi ufuna ukuhoxisa umshwalense. Kodwa lokho kuzoncika ekutheni inkampani ehlinzeka ngesikweto iyavuma yini ukwuhoxisa lo mshwalense futhi lokho kumele ikwenze ngencwadi ebalwe phansi.
- Onke ama-premium akhokhwe ngalesi sikhathi esiyizinsuku ezingama-30 ayobuyiselwa ngu-Guardrisk kuwe.

Ukubalwa kwe-premium

- I-premium ekhokhwayo iya ngokuthi ibhalansi yokuqala (inani lemali ezokhokhwa ngamancozuncozu ngenkathi kuqala isivumelwano sesikweto), njengoba kusho isivumelwaneni sakho sesikweto, ngaphandle kwesivumelwano sesikweto se-MobiMoney lapho i-premium iyabalwa ngokwenani lemali ezokhokhwa ngamancozuncozu enqunywe ngezikhathi ezithile. I-premium izabalwa kususelwa ku-R1,000 ngamunye wesamba semali esele esikweleni.

Izinsuku ezingushwele wokukhokhwa kwe-premium

- Kunesikhathi sikashwele sokukhokhwa kwe-premium esiyizinsuku ezingama-30 (amashumi amathathu) esivumlekile kusukela ngosuku olunqunye okumele kukhokhwe ngalo i-premium ngayinye. Ngalesi sikhathi, ngeke ihoxiswe imihlomo yomshwalense. Uma ngalesi sikhathi sikashwele kufakwa isicelo sokukhokhelwa esisemthethweni futhi esifanelekile, i-premium engakakhokhwa izodonswa emalini yomhlomulo ozokhokhwa ngumshwalense.
- Isikhathi sikashwele wokukhokhwa kwe-premium asisebenzi ekhokhweni kwe-premium yokuqala ngenkathi kuqala isikhathi sokuqala kokusebenza komshwalense.
- Uma i-premium ihlala ingakhokhelwe isikhathi esingaphezulu kwesikhathi sikashwele, ipholisi iyoyeka ukusebenza ngokuzenzakalela kanti imihlomo yonke iyoma ngokuhlizeka nanoma iyiphi ikhava.

Ama-premium kanye nokuchithshyelwa kwepholisi

- Abakwa-Guardrisk kungenzeka bawakhuphule ama-premium ngokuhamba kwesikhathi uma sebekunikeze isaziso esibhalwe phansi sezinsuku ezingama-30 (amashumi amathathu).
